Personal Data

Identifiable information may include, but is not limited to:

- Email address

- Family first and last names
- Entourage first and last names
- Itinerary information
- Identification documentation (passport, driver's license, residency cards, etc.)

Use of Data

My Travel Guardians uses the collected data for various purposes:

- To provide and maintain the Service
- To notify you about changes to our Service
- To allow you to participate in interactive features of our Service when you choose to do so
- To provide customer care and support
- To provide analysis or valuable information so that we can improve the Service
- To monitor the usage of the Service
- To detect, prevent and address technical issues

Transfer of Data

Your information, including Personal Data, may be transferred to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction. The regulations followed by My Travel Guardian is consistent with the laws and regulations of the state of Washington, USA.
